- Food merchants are also required to complete the Special Events Food Vendor Package when returning this registration form. Food vendors are also encouraged to read through the Sepcial event Food Vendor Package. They can be found on <https://www.albertahealthservices.ca/eph/page13999.aspx>
- Full payment and damage deposit are due upon returning the registration form. We accept Cheque payment, payable to **Chinatown Business Improvement Area** or e-transfer to csf@calgarychinatown.com. Early bird special till June 30, 2022.
- If you are paying with cheque, please prepare a seperate one for the damaage deposit, and it will be returned after the event. If you are e-transferring money, damage deposit will be refunded after August 22, 2022 by cheque if all rental equipments are left clean and undamaged.
- Food merchants must comply with Alberta Health Service and Calgary Fire regulations for food handling and serving and fire prevention. No exceptions. Open cooking is restricted to designated food service area. Pre-packaged food may be served in non-cooking tents.
- Ethical goods and services are only permitted. Illegally produced products or illicit servies is banned.
- All Tents participants are responsible for their own health, safety and security including insurance.
- Tent location can be reserved The event organizer has the final decision of tent location.
- The Event's operating hours are 11am to 7pm on August 20, 2022. Merchandise and Cultural merchants are allowed to operate as soon as they are set up. Food merchants to be ready to serve food when they are set up according to AHS guidelines (Alberta Health Inspections may be done at the beginning of the event).
